Details

Festival Hours: 11:00am – 10:00pm

Vendor fee covers (1) one 10x10 booth space located in the parking lot.

Booth locations will be assigned

A larger space may be provided upon request and may be subject to an additional fee.

Water is available onsite, though not supplied to booth locations.

There is no electricity available to vendors. Quiet generators only are permitted. Battery operated lights are recommended.

Arrival time: 7:00am – 10:00am. Vendors will not be permitted entry after 10:00am, no refund will be issued to late arrivals or no-shows.

Setup time: Vendor booth must be completely setup and vehicles parked in the designated vendor parking area.

Parking: Each vendor, no matter the booth Size, will be provided parking for 1 vehicle only (standard size car, truck, or van). Any additional vehicles must park in the public parking areas. No trailer parking permitted. Vendors with trailers may unload the trailer, then park it off site. To vehicles allowed in the gate after 10:00am.

Breakdown: Vendors may not breakdown or pack up any part of their booth until the end of the festival at 10:00pm. Upon departure, the assigned booth space must be clean with no trash or other items left. Trash is to be disposed of in the designated dumpster onsite.

No commission on sales is collected by Southern Star Brewing Company, Conroe Area Association or Conroe Americana Music Festival

Requirements

Vendors are required to provide:

1. 10' x 10' EZ Up Straight-leg tent, clean and in good condition, no color requirements.
2. Weights for each leg of the tents.
3. Tables and other equipment as needed

Displays and setup must stay within your assigned booth dimensions.

Exhibiting artists are required to display their booth number sign (distributed at check-in) in a prominent place within their booths.

No outside rentals or staking of tents. Weights and water barrels only. *Please be prepared with extra weights which may be necessary due to possible strong winds.*

Any breach of the rules forfeits all rights of the artist, and will result in immediate removal from the show without a refund.

No Music or other amplified sound is to be played by vendors or at vendor booths.

No firearms, guns or outside alcohol

Categories

- **Ceramics:** All original clay and porcelain work other than jewelry is accepted in this category.
- **Digital Art:** This category includes any original work for which the original image, or the manipulation of other source material, was executed by the artist using a computer. Traditional photographs taken through a digital media should apply in the photography category. Work that starts with a photograph and/or manipulated by digital means must be entered in either the Mixed Media or Photography category.
- **Drawing:** Works created using dry media including chalk, charcoal, pastels, pencil, wax crayon, etc. or from the fluid medium of inks and washes applied by pen or brush are to be entered in this category.
- **Fiber:** All work crafted from fibers including basketry, embroidery, weaving, tapestry and papermaking. No machine tooling, machine-screened patterns or other forms of mass production are permitted. No factory produced wearable items, regardless of additional modification or enhancement by the artist, may be exhibited.
- **Glass:** No forms of mass production are permitted.
- **Jewelry:** All jewelry whether the work is produced from metal, glass, clay, fiber, paper, plastic or other materials must be entered in this category. No commercial casts, molds or production studio work is allowed.
- **Leather:** Includes all works from leather. No production studio work is allowed.
- **Metalworks:** Includes all non-sculptural, non-jewelry works crafted from metals. No production studio work is allowed.
- **Mixed Media:** This category includes works, both 2 and 3-dimensional, that incorporate more than one type of physical material to produce. Includes non-sculptural work as determined by the artist. Please note two previous categories, 2D Mixed Media and 3D Mixed Media, have been combined into one Mixed Media category.
- **Painting:** Works created in oils, acrylics, watercolor, etc. are in this category.
- **Printmaking:** Printed works for which the artist's hand manipulated the plates, stones or screens and which have been properly signed and numbered as a limited edition may be entered in this category.
- **Photography:** Photographic prints made from the artist's original image, which have been processed by that artist, or under his or her direct supervision, are included in this category. Photographers are required to disclose both their creative and printing processes on prints which have been properly signed and numbered as a limited edition.
- **Sculpture:** Three-dimensional original work done in any medium, including built up works in wood are included in this category.
- **Wood:** Original works in wood that are hand-tooled, machine-worked, turned or carved are accepted in the wood category.
